Motion made and question proposed that, the House called on the State Government to construct a road from Madobi-Rikadawa-Jirgwai all in Madobi Local Government Area-**Hon. Kabiru Yusuf Isma'il(Madobi)**

Seconded by **Hon. Nuhu Abdullahi Achika (Wudil)**

Debate Arising:

- **Hon.Kabiru Hassan Dashi Deputy. Maj Leader (Kiru).** He lamented that road in the area negatively affects the livelihood of the people and in particular hampered their farming activities.
- **Hon. Hayatu Musa DorawarSallau Majority Whip (Kura/ G. Mallam)** reiterated that the construction of the road will facilitate movement of people around the area. He clarified that the motion is only affectthe people of Madobi.

RESOLVED

The House constituted a Joint Committee consisting of Committees on Emergency Relief, Rural Development and Housing, to report in one week.

ANALYSIS
