**KANO STATE HOUSE OF ASSEMBLY

VOTES AND PROCEEDINGS  
MONDAY 30<sup>TH</sup> NOVEMBER, 2020  
(14<sup>TH</sup> RABI'UL THANI, 1442 A.H.)**

1. The House met at 11:32 a.m. Mr. Speaker took his seat and read prayers.

**2. MESSAGE FROM THE GOVERNOR**

Mr. Speaker announced the receipt of four Bills from His Excellency, the Executive Governor of Kano State, **Dr. Abdullahi Umar Ganduje, OFR (Khadimul Islam)**.

- a) A Bill for a Law to establish Kano State Skills Acquisition Centre charged with responsibility for training, coordinating and imparting occupational and entrepreneurial Skills and for other matters connected therewith
- b) A Bill for a Law to provide for the Kano State Commercial Vehicles (Road Cabotage and Haulage) Fees Bill, 2020 (1442 A.H.) and for matters connected therewith.

- c) A Bill for a Law to provide for effective management and control of Muhammad Abubakar Rimi (Sabon Gari) Market Kano and for matters connected therewith.
- d) A Bill for a Law to establish a Corporation for effective management of Kantin Kwari Market, Kano and for matters connected therewith.

Mr. Speaker ordered the Clerk to the House, to proceed with further legislative processes.

Mr. Speaker further announced the receipt of another letter from His Excellency, the Executive Governor of Kano State, **Dr. Abdullahi Umar Ganduje, OFR (Khadimul Islam)** conveying request to secure Central Bank of Nigeria (CBN) Infrastructural Facility Fund in the sum of **Twenty Billion Naira (N20,000,000,000)** through the United Bank for Africa (UBA).

By the provision of Order II, Rule 2(b), **Hon. Kabiru Hassan Dashi, Majority Leader (Kiru)** moved that, the House do now proceed to deliberate on the matter.

Seconded by **Hon. Labaran Abdul Madari (Warawa)**.

The House approved the request of His Excellency, the Executive Governor of Kano State, **Dr. Abdullahi Umar Ganduje, OFR (Khadimul Islam)** to access **Twenty Billion Naira (N20,000,000,000)** loan facility from the Central Bank of Nigeria through the United Bank for Africa (UBA).
